RIPE NCC Conflict Arbitration Procedure (1)

Scope: i) Settlement of disputes

•Between:

- Members and the RIPE NCC with respect to the RIPE NCC Standard Service Agreement
- Two or more Members regarding the registration of Internet number resources
- Legacy Internet Resource Holders and the RIPE NCC regarding decisions of the Executive Board or the Management Team for the implementation of the RIPE Policy 'RIPE NCC Services to Legacy Internet Resource Holders'

•Procedure:

- Actions from the Arbiter
- Submission of information
- Arbiter's ruling & its execution

RIPE NCC Conflict Arbitration Procedure (2)

Scope: ii) Evaluation of requests for Internet number resources by the RIPE NCC

- Initiated by the RIPE NCC
- Evaluated by the majority of the Arbiters Panel
- •In accordance with the RIPE Policy 'Allocating/Assigning Resources to the RIPE NCC' (https://www.ripe.net/publications/docs/ripe-635)
