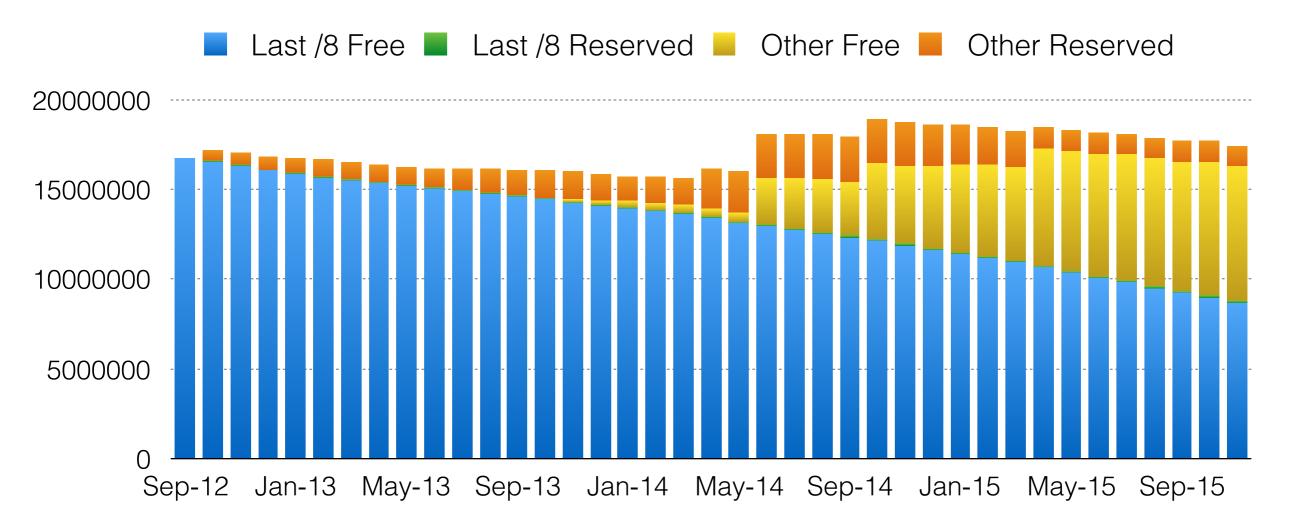

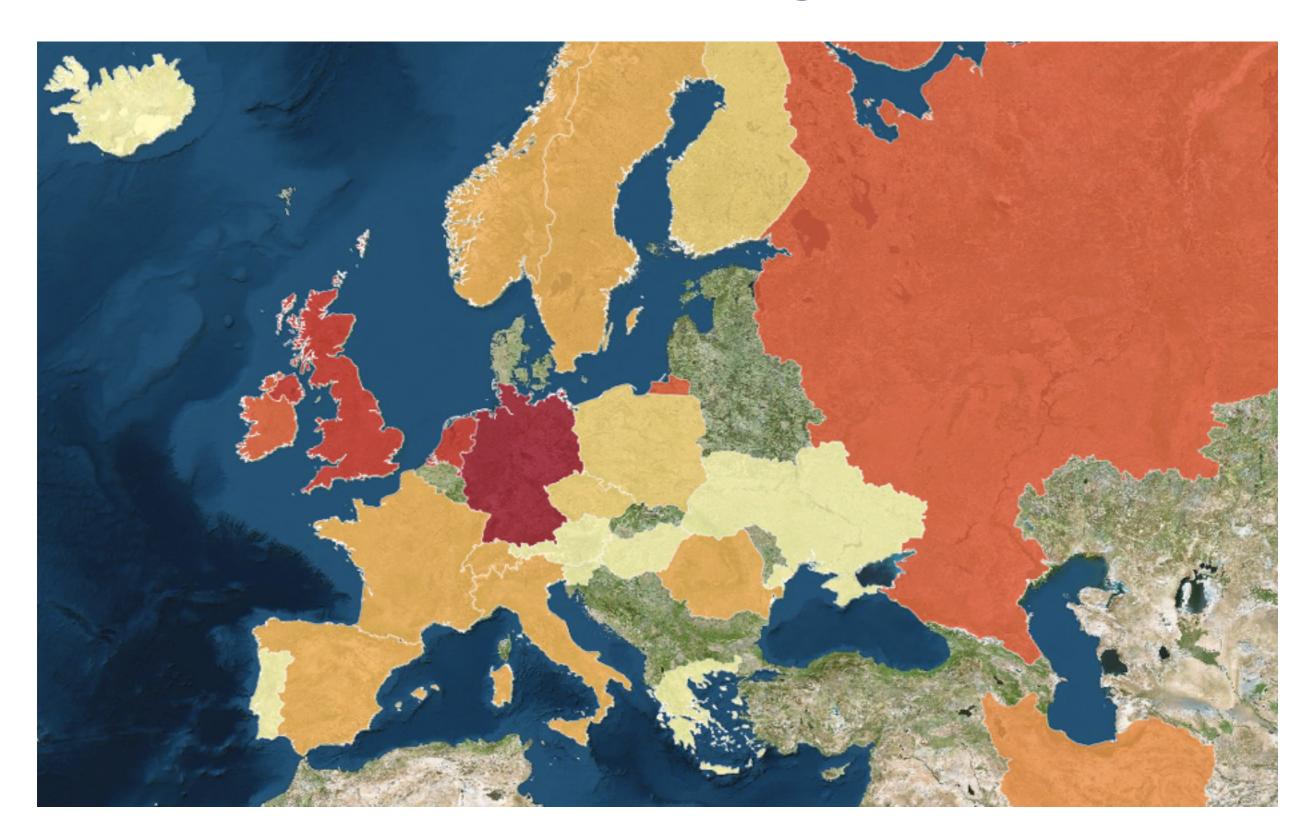


- Over 1,400 posts to the Address Policy WG mailing list

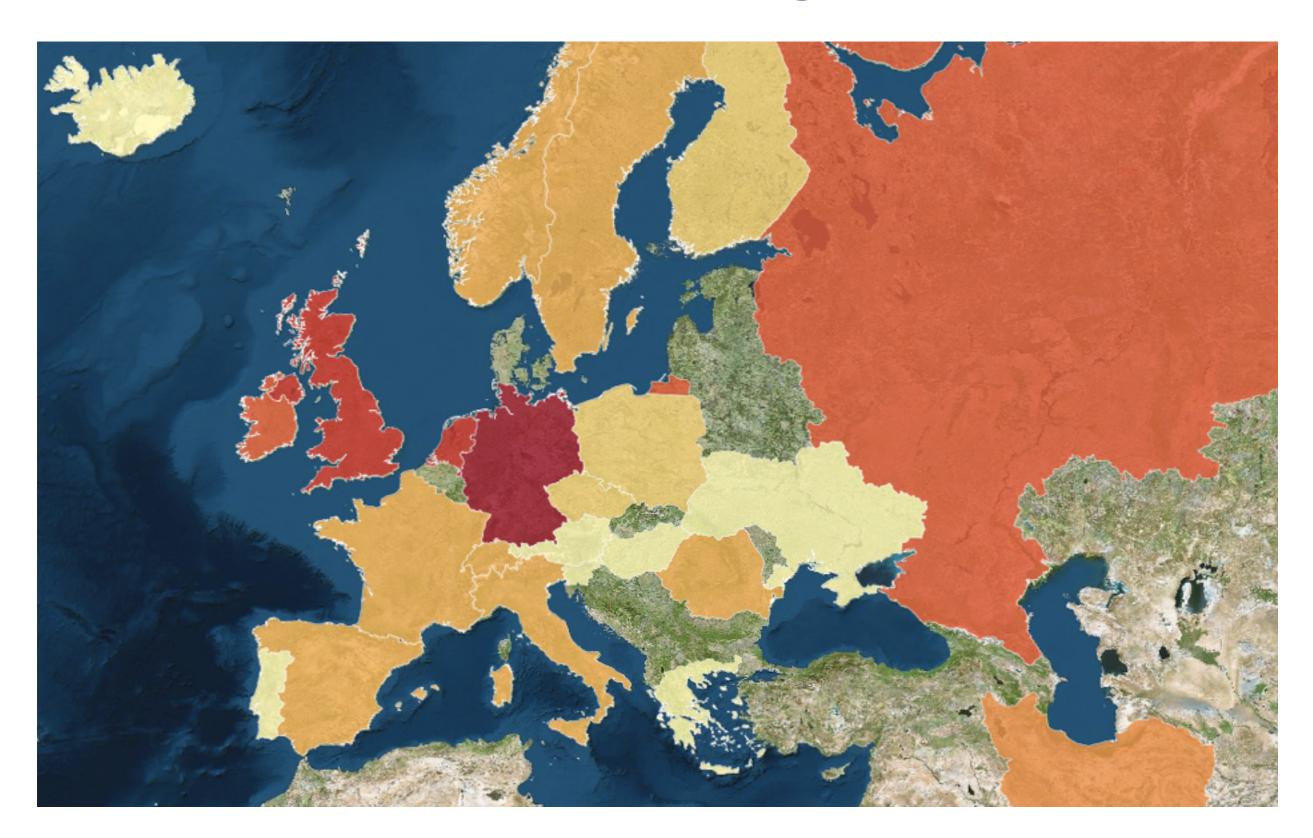

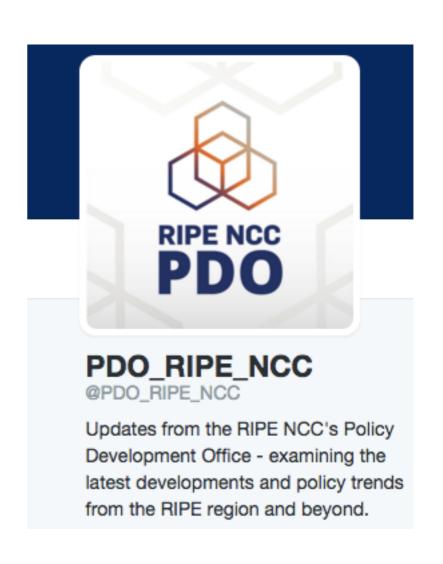
